## **GENERAL TERMS AND CONDITIONS**

It is important to understand the following, as registering for language courses implies full acceptance of these terms and conditions.

## VISA REQUIREMENTS : No visa is required for EU citizens

#### For Non-EU Citizens:

- For stays of up to 3 months, you must apply for a tourist visa at the French Consulate in your country.
- For stays **longer than 3 months**, you must apply for a **long-stay student visa**, which entitles you to a residence card, at the French Consulate in your country. **The International Summer University of Nice** provides the necessary documentation for visa applications but is not authorized to intervene in the visa issuance process.

## PAYMENT TERMS

#### Registration fees must be paid in full before the start of the course.

- All payments must be made in euros (€).
- Payments can be made by credit card at the office (Room H230, Campus Carlone) or online.

You will receive confirmation once we have received the required documents and your registration progress. If your application is successful, we will send you the link to proceed with the online payment.

## Bank transfers are no longer accepted.

- For one-session registration (Session 1, 2, or 3), full payment of €480 (€250 for UniCA students) is required.
- For registration for two consecutive sessions, a deposit of €480 (€250 for UniCA students) is required.

#### The remaining balance must be paid no later than two weeks before the start of the course.

Accommodation fees must be paid <u>directly to the service provider via their bank account</u>. Banking details will be provided upon booking.

## **COURSE CANCELLATION**

The International Summer University of Nice reserves the right to cancel a session depending on the number of participants, up to 15 days before the start of the course

## CANCELLATION AND REFUNDS
