## GENERAL CONDITIONS

It is recommended to understand the following, as your registration for the language courses implies full acceptance of these general conditions.

**VISA:** If you are a European Union national, you are exempt from a visa. If you are not a European Union national:

For a stay of up to **3 months**, you must apply for **a tourist visa** at the French Consulate in your country.

For a stay **longer than 3 months**, you must apply for **a long-stay student visa**, which grants the residence permit, at the French Consulate in your country. **International Summer School of Nice** provides the necessary certificates for visa applications but is not authorized to intervene in the visa issuance process.

### **PAYMENT METHOD:**

-All payments must be made in euros (€).

-Payments can be made by credit card at the secretariat located in office H230 at the Carlone Campus or online. We will confirm receipt of the required documents and the progress of your registration.

If your application is accepted, we will send you the link to make the online payment.

For registration for a single session (Session 1, 2, or 3), the full amount of 520 € (or 320 € if you are a UniCA student) is required.

For registration for two consecutive sessions, a deposit of 520 € (or 320 € if you are a UniCA student) is required. The balance must be received no later than **two weeks before the start of the course**.

Accommodation fees are to be paid directly to our provider's bank account. We will provide their banking details at the time of booking.

### **CANCELLATION OF COURSES:**

International Summer School of Nice reserves the right to cancel a session based on the number of registrations up to 15 days before the start of the course and may modify the cultural and sports activities program.
